Subject: Submission to the National Planning Framework - Cllr David Saurin

I wish to make this submission calling for Drogheda's inclusion in the National Planning Framework and for the town to be designated City Status. Drogheda's large population justifies it's need to be included in this Process and it's demand to be designated City Status. It is currently the largest town in the country and indeed it's population exceeds that of Waterford City.

Drogheda's location on the M1 motorway with it's ease of access to the cities of Dublin and Belfast make it an attractive location for investment. It has the available landbanks including an IDA business park to facilitate both further growth in Industry and in Population and Housing. Also it's proximity to Dublin Airport and it's Rail Service along with it's Port make it a prime location for the distribution of goods and materials and access to markets, further justifying it's inclusion in the NPF.

Drogheda is in a position to meet strategic demands in terms of facilities and infrastructure, the Lourdes Hospital is the main regional hospital for the entire North Eastern Region. The town is also serviced by a Waste Treatment Plant with a capacity to cater for a further increase in population. Also the recent construction of a new Courthouse has added to the Civic facilities that are already available in the town

Drogheda also has much to offer in the area of Tourism and Recreation with it's rich history and folklore associated with the River Boyne and it's historic structures such as Laurence's Gate and the Boyne Viaduct and it's many fine Golf Courses in the surrounding area. As well as it's inclusion in Ireland's Ancient East tourist trail.

These are only a small example of Drogheda's many attributes that justifies it's need for inclusion in the National Planning Framework and it's demand for City Status.
