## Dear ministers,

This submission is regarding Drogheda and all it's future endeavours. Drogheda has been my home for most of my life but I have studied in Dublin and lived in Maynooth also. I am 25 years of age and I feel like my perspective is very relevant to the creation of the proposed framework; for it is my age group that will be in your position by the time these plans are in full effect. 20 years from now I can see Drogheda being a hub of prosperity and a key player for growth in Ireland.

Over the years, Drogheda has grown regardless of losing it's Town Council and the lack of investment it has received due to worsening economic conditions. The town having heavy Traffic (which is because of people driving through the town to avoid the M1 Toll) and having no proper third level education still have not affected the growth of the town. Drogheda was one of the only towns in the country that was selling houses built during the gratuitous era of over-planning for housing estates. We have built two new state of the art schools and refurbished many long standing ones, but these kids will have to venture out of the town to receive the education and training they desire which brings me to the conclusion of this point. The low corporation tax which attracts big players is not something we can rely on as Europe squeezes it's grip on Ireland's legislation. IT is always growing but the playing field has changed. More can be done with less physical expansion and the investment for new buildings is not primarily affixed to Dublin. The company "MTI Global Services" have recently opened a new facility in Drogheda, again, regardless of the town even having it's own council. This signals that the town is in the perfect location for investment whether it be foreign or national. I propose that if Drogheda was granted city status and the funding required to set up an office that solely dealt with attracting FDI the results would be a salvation for the town and the north east.
