Thank-you for your email regarding the Strategic Environmental Assessment (SEA) Scoping Report for the Ireland 2040 National Planning Framework.

The Department of Agriculture, Environment and Rural Affairs Northern Ireland (DAERA) has considered the consultation and associated documents and our opinions are set out below.

Biodiversity Flora and Fauna

4. Relevant Plans and Programmes

The following plans and programmes relating to Northern Ireland could also be considered:

 Any relevant current or emerging Local Development Plans in Northern Ireland which share a border with the Republic of Ireland (Fermanagh and Omagh, Newry, Mourne and Down, Derry City and Strabane, Armagh, Banbridge and Craigavon District Council and Mid Ulster District Council) should be taken into account in the development of the SEA.

5.3.2 Biodiversity Flora and Fauna

We suggest changing the wording of the draft SEA objective from <u>restore</u> to <u>enhance</u> the terrestrial, aquatic and soil biodiversity, particularly EU designated sites and protected species.

Marine

We would like to highlight three newly proposed European designated sites and one nationally designated site which was recently adopted under the Marine Act (Northern Ireland) 2013, that need to be taken into consideration in environment report which are within close proximity to trans-boundary waters.

- Carlingford Marine proposed SPA which is designated under the EC Birds Directive (79/409/EEC on the conservation of wild birds). The site selection features is seabirds.
- Carlingford MCZ which is designated under the Marine Act (Northern Ireland) 2013. The site selection features are Subtidal (sublittoral) mud: Philine aperta (white lobe shell) and Virgularia mirabilis (Sea-Pen) in soft stable infralittoral mud.
- North Channel pSAC which is designated under the EC Habitats
 Directive (92/43/EEC on the conservation of natural habitats and of wild







fauna and flora). The site selection feature is Harbour porpoise. http://jncc.defra.gov.uk/page-7242

 East Coast Marine pSPA which is designated under the EC Birds Directive (79/409/EEC on the conservation of wild birds). The site selection features is seabirds.

Climate Change

Chapter 4, Table 4.1

We consider the EU Strategy on Adaptation to Climate Change 2013 should also be listed.

Air Quality

We consider that detailed assessment in the Environmental Report should take account of the following potential areas for transboundary air pollution impacts:

- Where planning policy has any impact or effect on agricultural land use and/or intensive agricultural housing, then consideration of agricultural emissions (in particular, ammonia emissions) on habitats in border areas. http://www.apis.ac.uk/ provides a breakdown of ammonia sources for protected sites in Northern Ireland;
- The potential for impacts from air pollutant emissions from industrial, residential or road transport in border areas.
